

PRIVACY POLICY

Krasnodar

2nd April, 2018

This Privacy Policy of personal data (hereinafter referred to as the Privacy Policy) applies to all the information posted on the website on the Internet at <https://renteto.com>, <https://renteto.ru> (hereinafter referred to as the Site), which the visitors to the site can get about the User while using the Site, its services, programs and products.

Using the services of the Site means the unconditional consent of the User with this Policy and the conditions for processing his personal data specified in it; in case of disagreement with these conditions, the User should refrain from using the services.

1. GENERAL REQUIREMENTS

- 1.1. In the conduct of this Policy, the personal information of the User means:
 - 1.1.1. Personal information that the User provides about himself independently during the booking process or during registration (account creation) or in the process of using the Services, including the User's personal data. Information required for the provision of the Services is marked in a special way. Other information is provided by the User at his discretion.
 - 1.1.2. Data that is automatically transferred to the Site services in the course of their use with the help of the software installed on the User's device, including IP address, cookie data, information about the User's browser (or other program that is used to access the services), technical characteristics of the equipment and software used by the User, date and time of access to services, addresses of requested pages and other similar information.
 - 1.1.3. This Privacy Policy applies only to the Site <https://renteto.com> and <https://renteto.ru>. The site <https://renteto.com> and <https://renteto.ru> does not control and is not responsible for the third-party sites which the User can follow by clicking on the links available on the Site.

2. OBJECTIVES OF PROCESSING USER'S PERSONAL DATA

- 2.1. The site collects and stores only that personal information that is necessary for the provision of services or the execution of agreements and contracts with the User, unless the law provides for the obligatory storage of personal data for a period specified by the law.
- 2.2. The Site processes the User's personal data for the following objectives:
 - 2.2.1. Identification of the User registered on the Site.
 - 2.2.2. Establishing feedback with the User, including sending notifications, requests regarding the use of the Site, the provision of services, processing requests and applications from the User.
 - 2.2.3. Determining the location of the User to ensure security and prevent fraud.
 - 2.2.4. Confirmation of the accuracy and completeness of personal data provided by the User.
 - 2.2.5. Creation of the account for posting the information about the services provided.
 - 2.2.6. Providing the User with effective customer and technical support in case of problems associated with the use of the Site.
 - 2.2.7. Pursuit of promotional activities with the consent of the User.

3. TERMS OF PROCESSING THE USER'S PERSONAL DATA AND ITS TRANSFER TO THIRD PARTIES

- 3.1. The site stores User's personal data in accordance with the internal regulations of specific services.
- 3.2. With regard to the User's personal data, its confidentiality is maintained, except for cases when the User voluntarily provides information about himself for general access to an unlimited number of people. When using certain services, the User agrees that a certain part of his personal information becomes publicly available.
- 3.3. The website has the right to transfer the User's personal data to third parties in the following cases:
 - 3.3.1. The User expressed his consent to do it.
 - 3.3.2. The transfer is necessary for the use by the User of a certain service or for the execution of a specific agreement or contract with the User.
 - 3.3.3. The transfer is provided for by Russian or other applicable legislation within the framework of the procedure established by law.
 - 3.3.4. In the event of the sale of the Site, all the obligations to comply with the terms of this Policy with respect to the personal data received by him are transferred to the acquirer.
- 3.4. The processing of the User's personal data is carried out without any time limit by any legal means, including the personal data information systems using automation tools or without using such tools. The processing of User's personal data is carried out in accordance with the Federal Law of the Russian Federation of July 27, 2006 No. 152-Φ3 "On Personal Data".
- 3.5. In case of loss or disclosure of personal data, the Site Administration informs the User about the loss or disclosure of personal data.
- 3.6. The Site Administration takes the necessary organizational and technical measures to protect the User's personal data from unauthorized or accidental access, destruction, alteration, blocking, copying, distribution, as well as from other illegal actions of third parties.
- 3.7. The Site Administration together with the User takes all necessary measures to prevent losses or other negative consequences caused by the loss or disclosure of the User's personal data.

4. OBLIGATIONS OF THE PARTIES.

- 4.3. The User is obliged to:
 - 4.3.1. Provide information about personal data that is necessary to use the Site.
 - 4.3.2. Update, supplement the provided information about personal data in case of change of this information.
- 4.4. Site Administration is obliged to:
 - 4.4.1. Use the information received solely for the purposes specified in this Privacy Policy.
 - 4.4.2. Ensure the storage of confidential information in secret, not to disclose it without the prior written permission made by the User, and also not to sell, exchange, publish or disclose in any other possible way the transmitted personal data of the User, except as provided for in this Privacy Policy.
 - 4.4.3. Take precautions to protect the confidentiality of the User's personal data in accordance with the procedure usually used to protect this kind of information in existing business transactions.
 - 4.4.4. Block personal data related to the relevant User from the moment of contacting or requesting the User or his legal representative or authorized body for the protection of the rights of personal data subjects for the period of verification in case of revealing inaccurate personal data or illegal actions.

5. LIABILITY OF THE PARTIES

- 5.3. The Site Administration, which has not fulfilled its obligations, is liable for losses incurred by the User in connection with the unlawful use of personal data, in accordance with the legislation of the Russian Federation.
- 5.4. In case of loss or disclosure of confidential information, the Site Administration is not responsible if this confidential information:
 - 5.4.1. It became public before its loss or disclosure.
 - 5.4.2. It was received from a third party until it was received by the Site Administration.
 - 5.4.3. It was disclosed with the consent of the User.

6. DISPUTE RESOLUTION

- 6.3. Before applying to the court with a claim for disputes arising from the relationship between the Site User and the Site Administration, it is mandatory to submit a claim (a written proposal for the voluntary settlement of the dispute).
- 6.4. The receiver of the claim within 30 (thirty) calendar days from the date of its receipt shall notify the claimant in writing of the following consideration of the claim.
- 6.5. If an agreement is not reached, the dispute will be referred to the court in accordance with the current legislation of the Russian Federation.
- 6.6. The current legislation of the Russian Federation applies to this Privacy Policy and the relationship between the User and the Site Administration.

7. ADDITIONAL CONDITIONS

- 7.3. The Site Administration has the right to make changes to this Privacy Policy without the User's consent.
- 7.4. The new Privacy Policy comes into force from the moment it is posted on the Site, unless otherwise provided by the new version of the Privacy Policy.
